a) **Application Ref: P22/S3470/FUL: 34 Blackthorn Rise Tetsworth OX9 7DZ**

Reconstruction of end of terrace dwelling from first floor up following extensive fire damage. **Comments UNANIMOUSLY AGREED and to be submitted by the Clerk:** *Tetsworth Parish Council (TPC) unanimously agreed their support of this application.*

b) **Application Ref: P22/S3276/FUL: Greenwood Cottage, 30 Silver Street Tetsworth**

Erection of single storey oak-framed dwelling.

Comments UNANIMOUSLY AGREED and to be submitted by the Clerk: *Tetsworth Parish Council (TPC) agreed their support of this application provided that highway specialists are satisfied with parking arrangements.*

161. **To Consider the provision of Warm Spaces in Tetsworth**


162. **Date of next meeting:** The next meeting will be held on **Monday 14th November 2022 at 7.30pm**
